7. Annual Report

a) Presentation and general overview of achievements by the Mayor

The Mayor tabled the Annual Report and provided a general overview of Council's achievements and highlights which occurred during the year.

On behalf of Council the Mayor thanked the Chief Executive Officer and his staff for their dedication and their professional advice and support provided to Council and the City of Clarence.

The Mayor conveyed his appreciation to his fellow councillors, for another year of dedication, hard work and commitment to the community.

b) Presentation by Chief Executive Officer

The Chief Executive Officer provided a summary of the operational activities of the City of Clarence over the past 12 months. He acknowledged the dedication and professionalism of the staff and thanked the Mayor and Councillors for their leadership and decision making over the past twelve months.

c) Presentation of Council's Financial Report by the Chief Financial Officer

The Chief Financial Officer gave a detailed overview of the Financial Statements in the Annual Report and Council's overall financial performance.

d) Summary of any submissions received – none received

The Mayor advised the Meeting that there were no submissions on the Annual Report received prior to the meeting.

e) Discussion on submissions received – none received

As there had been no submissions received no discussion occurred in respect to this item.

f) Motion to adopt Annual Report

Before putting the Motion the Mayor invited questions from Councillors regarding the Annual Report.

Cr James asked the following questions

Question 1

On page 66 of the Annual Report under Buildings it shows fair value at 30 June 2025 of 75 million at 2024 - 50.5 million less accumulated depreciation of 8 and 7 million respectively. My question is that increase from 50 to 75 the purchase of 30 Gordons Hill Road and if so is there any accumulated depreciation in the 2025 amount which is shown on page 66?



ANSWER

The Chief Financial Officer advised that some of that amount would be the purchase of 30 Gordons Hill Road and as that was purchased late at the end of June there would be very little depreciation.

Question 2

There was 66 million in profit for the year ending 2025 of which 34 million is part of the revaluation. There is another 32 million, can you explain the source of that?

ANSWER

The Chief Financial Officer advised that there is 36 million from the revaluation of stormwater assets, and there would also be contributions of 15 million associated with contributed assets and the revaluation of Taswater as well as some other small items

Cr Mulder asked the following Question

Regarding the cash balance which we have just been advised has decreased by 10 million dollars over the last financial year, what is the balance now in real terms and what is the balance projected to be under our ten year financial strategy?

ANSWER

The Chief Financial Officer advised that as at 30 June the balance was 81.5 and took the second part of the question on notice



Cr Walker asked the following questions

Question 1

Page 71 refers to the defined benefit plan and that there are still employees under that plan. where are we going with that are our liabilities increasing each year or are we starting to tail down in this area?

ANSWER

The Chief Executive Officer advised that advice had been received some weeks ago that there are no additional contributions required from council for defined benefits because the fund has sufficient to generate the income it needs.

Question 2

I assume that depending on how the investment class goes we could still be asked to make a call if things go south?

ANSWER

The Chief Executive Officer advised that was correct but for several years there has not been a call, and that council receives updates each year following 30 June.

 - Cr Hulme reported from the Disability Access and Inclusion Working Group highlighting the attendance at the group's end of year event of the inaugural Disability Commissioner and further noted the group's input throughout the year into various council projects.

 - reported from the Sustainability Advisory Committee and the expected finalisation of the Sustainability Action Plan; and
 - noted the input of the Bicycle Advisory Working Group into various projects throughout the year.
 - Cr Chong acknowledged the work of the outgoing Chairperson of the Audit Panel,
 Mr Richard Easther after the conclusion of his eight year term as independent Panel
 Member.

The Mayor thanked Councillors for their involvement at a Committee and Working Group level and acknowledged the input from community members.
